

Privacy Policy (NZ)

WHY YOUR PRIVACY MATTERS TO US

The Treehutvillage Pty. Ltd. (NZCN 6328009) (“THV”) is committed to keeping your information safe and secure in accordance with the Privacy Act 1993 (the “Privacy Act”) and the Information Privacy Principles contained therein. By engaging THV’s services, you are giving consent to THV for the use of your private information in the manner set out in this Privacy Policy.

COLLECTING YOUR PERSONAL INFORMATION

THV may collect and use the following kinds of information:

- information about your use of the services of THV, including but not limited to our website at treehutvillage.co.nz (the “Services”); and
- information about your personal details (including name; phone contact details; address information; email; employer; career history and current salary).

Information about your personal details may be collected from you in a variety of ways, including but not limited to: when you interact with the Services electronically or in person; when you access the Services; via the internet; and when THV provides services to you.

HOW WE USE YOUR PERSONAL INFORMATION

THV may use your personal information:

- to enable your access to the Services;
- to track usage and measure statistics in connection with the Services;
- to supply to you the Services to you as a customer;
- to receive and/or access information from third party providers for the provision of our services to you;
- to contact you regarding your use of the services or services offered by THV;
- to contact you in relation to comments, complaints, enquiries or dispute resolution; and
- to communicate with third party providers or associate parties with respect to the provision of the services.

THV may be required to disclose personal information about you to third parties where it is required, incidental or otherwise related to the primary purpose of providing services to you.

You acknowledge and agree that, pursuant to the nature of the Services, THV may elect not to disclose the identity of these third parties to you.

THV, in its sole discretion, may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and in order to establish, exercise or defend its legal rights.

KEEPING YOUR INFORMATION SECURE AND ACCURATE

It is important that you advise THV of changes to your personal information that you have provided to THV as it is essential that your personal information is accurate, complete, and up-to-date in order for THV to provide services to you.

THV uses reasonable technical precautions and has implemented business processes to protect your personal information from misuse, loss, unauthorised access, modification and disclosure. However THV is not liable for any unauthorised access to this information.

THV will take all reasonable steps to destroy or permanently de-identify personal information if it is no longer needed for the purposes of providing our services to you and where THV is not required to retain that information by law.

ACCESS AND CORRECTION

As a potential customer, you are responsible for ensuring that the information you provide to THV is accurate, complete and up-to-date.

By request, you may contact THV and ask to know what sort of personal information is held about you, for what purposes, and how it is collected, held, used and disclosed.

By request, you may access your personal information by contacting THV at info@treehutvillage.co.nz. THV reserves the right to charge a reasonable administration fee in accordance with the Privacy Act.

THV, in its sole discretion, may consider that there is a sound reason under the Privacy Act, Freedom of Information Act or other relevant law to withhold personal information, or not make the requested changes.

IDENTIFIERS AND ANONYMITY

You acknowledge that THV retains, collects and maintains your personal information for statistical analysis purposes (for internal use only). You agree that THV may share, distribute and/or transfer information which you have provided to THV to third parties, after that information has been de-identified.

YOUR PRIVACY AND TRANS-BORDER DATA FLOWS

You acknowledge that THV's servers may be situated outside of New Zealand and therefore, your personal information may be transferred and stored in foreign jurisdictions. You agree that THV may transfer your information into foreign jurisdictions for the purposes of providing you with the Services. In addition to the above, THV will only transfer personal information to someone who is in a foreign country where:

- THV reasonably believes that the recipient of the information is subject to a law, binding scheme or contract which effectively upholds principles for fair handling of the information that are substantially similar to the Information Privacy Principles;
- the individual consents to the transfer;
- the transfer is necessary for the performance of a contract between you and THV, or for the implementation of pre-contractual measures taken in response to your request;

the transfer is necessary for the conclusion or performance of a contract concluded in your interest between THV and a third party;

- all of the following apply:
 - the transfer is for your benefit;
 - it is impracticable to obtain your consent to that transfer; and
 - if it were practicable to obtain such consent, you would be likely to give it; or
 - THV has taken reasonable steps to ensure that the information which it has transferred will not be held, used or disclosed by the recipient of the information inconsistently with the Information Privacy Principles.

QUESTIONS OR COMPLAINTS

A complaint should identify whether it is about:

- the collection of personal information;
- the use of personal information;
- the disclosure of personal information;
- the security or storage of personal information;
- the accuracy of personal information;
- a refusal to give complaint access to or find out about their personal information; or

- a refusal to change or delete personal information.

THV values your opinions and takes complaints very seriously. Upon receiving written notice of your complaint about privacy, THV will respond quickly to advise you of the outcome following its enquiring into the same. You will also be invited to respond to its outcome. If a response is received, THV will assess it and advise if it has changed its view. If you are unsatisfied with the final outcome, THV will advise further options and you can also lodge a complaint with the Office of the Privacy Commissioner.

MISCELLANEOUS

No partnership or agency

Nothing contained or implied in this Privacy Policy will create or constitute, or be deemed to create or constitute, a partnership between you and THV. A party must not act, represent or hold itself out as having authority to act as the agent of the other party or in any way bind or commit the other parties to any obligation.

Waivers

In limited circumstances, THV may allow you to waive application of this Privacy Policy. A waiver of this Privacy Policy must be in writing and signed by THV. THV anticipates that the waiver of this Privacy Policy would only be in exceptional circumstances, and THV encourages that you consider the circumstances leading to the waiver request prior to submitting such a request.

Governing Law & Jurisdiction

This Privacy Policy is governed by the laws of New Zealand. In the event of any dispute arising out of or in connection with this Privacy Policy, you agree that the exclusive venue for resolving any dispute shall be Auckland, New Zealand.

VARIATION TO THIS PRIVACY POLICY

This Privacy Policy is available online via treehutvillage.co.nz by clicking the “Privacy Policy” link located at the bottom of the Services. THV reserves the right to modify or amend this Privacy Policy at any time and for any reason, without notification. THV updates this Privacy Policy from time to time by posting a new version on its Services. You shall be taken to agree to the Privacy Policy from the time the new policy is posted on its Services.
